Highlights included: ED Tina Scott announced her plans for retirement as of 2/21/20; Jenn Champ began work as a full time Library Associate III on 12/16/19; Tina Scott and Annie Greene attended a 3 day NYLA Conference in Saratoga Springs, NY; 2 community events were held (local children's book author Ashleigh Calimeri's release party and Preceptor Alpha Upsilon (BEO Sorority) hosted a multicultural nativity exhibit) which brought in over 150 visitors; The Lenna Foundation awarded the Library a \$50,000 grant to be used for operating funds in 2020; there were 117 programs held in the month of November with 1073 in attendance and volunteer hours were 31.75 for the month.
